



## The Higher Education Emergency Relief Fund II (HEERF II)

According to the electronic announcement published on January 14, 2021. The Higher Education Emergency Relief Fund II (HEERF II) authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260, signed into law on Dec. 27, 2020.

Emma's Beauty Academy (03075600) acknowledges that it has signed and returned to the Department of Education on April 8, 2021 the Certification and Agreement (CFDA 84.425Q) (a)(4) Program). The funds available to proprietary institutions under the CARES Act, the only allowable use of funds for the grants provided under section 314(a)(4) of the CRRSAA is to provide financial aid grants to students.

The total amount of funds that our Institution received from the Department is \$521,891.00 pursuant to the Certification and Agreement [for] HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4).

The total number of students who have received on May 24, 2021 the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 117 students.

The total number of students who have received on August 10, 2021 the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 34 students.

The total number of students who have received on September 21, 2021 the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 41 students.

The total number of students who have received on November 9, 2021 the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 15 students.

The total number of students who have received on January 14, 2022 the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 80 students.

The total number of students who have received the HEERF II Allocations for Proprietary Institutions under CRRSAA section 314(a)(4) is of 287 students.

Per Federal regulations, funds will be distributed to students with exceptional need. Students who qualify to participate in emergency grant funds will be receiving assistance from the HEERF II based on their Expected Family Contribution, EFC, reported income information on the FAFSA.

The Financial Aid Office proceeded to evaluate the EFC of each eligible student. The amount of aid was awarded based on each student's EFC.

The amount of the grant was disbursed to each qualifying student in a single installment and it was sent by post mail. An informative letter was included explaining that the award amount may be used to help cover expenses related to tuition, materials, technology, food, housing, healthcare, childcare, or other emergency costs.
